1.1.1 Tracking country of origin

Information of country of origin will be gathered in conjunction with the sales of NFT on our website. This information is necessary for reporting sales and Value Added Tax to the tax authorities in the European Union. This kind of Information, which is related to bookkeeping according to the Swedish GAAP (Generally Accepted Accounting Principle) will be stored for at least 7 years.

1.1.2 Tracking cookies data

We use cookies and similar tracking technologies to track the activity on our Service and hold certain information.

Cookies are files with a small amount of data which may include an anonymous unique identifier. Cookies are sent to your browser from a website and stored on your device. Tracking technologies also used are beacons, tags, and scripts to collect and track information and to improve and analyze our Service.
